Tournament Rules

Open scramble

Played from White Tees for all in foursome. Callaway scored event. Each team must use 2 tee shots from every player in foursome. Maximum 2 mulligans per player will be available for purchase at registration, Play follows best ball selection scramble format for shot use.

Ladies’ Scramble

Play from Women’s Tees. All members of team are women. Callaway scored event. Each team must use 2 tee shots from each player foursome. Maximum 2 mulligans per player will be available for purchase at registration. Play follows best ball selection scramble format for shot use.

[Note: for the open scramble and ladies scramble final scoring will be on a Callaway system.]

Blue Tee Champion Flight

Played from Blue Tees. No mulligans available. Additional entry fee of \$100.00 at registration per team. Pot from additional entry fee will be split 50/50 between Charle Street and winning team. Must use 2 tee shots from each member of foursome: after tee shot each player will play their own ball to completion of the hole. All 4 scores are recorded and the two best scores on each hole will be used in scoring.
